Message from the Board

SFL PONDS & WEEDS

There have been concerns regarding the unsightly, wild growth of weeds around the ponds. Dormant grass can start towards the end of November and can last until the beginning of March. You may notice that your *grass* isn't growing as fast as normal, or that it doesn't require as much water, but *the weeds continue to grow*. These are Winter perennials weeds that flourish during the cool months and go dormant at the onset of summer heat. Currently, we do not have weed control in the vicinity of water tables of our ponds. Chemical applications are limited and if we spray the weeds in non-irrigated areas we will have sand. During the winter, lawn maintenance is reduced according to the rate of grass growth, or every 2-3 weeks. This wait is when we notice the perennial weed growth the most. Going forward, the lawn maintenance will address the weeds during the winter months and a plan for safely implementing the use of herbicides without causing damage throughout the year.

Did You Know?

Cooking Oil Recycling Effort (C.O.R.E.)

Hillsborough County's Cooking Oil Recycling Effort is for residential cooking oil. Used cooking oils are a serious problem for home plumbing and Hillsborough's County wastewater collection system. Cooking oils that are poured down the drain gels and solidifies inside pipes, sewage lines and sewage lift stations, constricting water flow. That can back up home plumbing and also cause equipment to malfunction. This leads to sewage spills, overflows onto streets, and foul odors in homes and neighborhoods.

Commercial and industrial customers must contact a licensed commercial grease hauler for cooking oil disposal.

Property Easements and Right of Way

Easements are:

 Areas of your property used for utilities, storm water drainage, sewer lines, etc.

Easements are not:

- To be built on or permanently obstructed without prior authorization.
- The same size, type or location for every property.

Common Types of Easements

- Utility
- Access
- Drainage
- Temporary construction

Right of Way (ROW) is:

- Compromised of the public and private areas of land dedicated to public travel or the provision of utility services.
- Sidewalks and grassy areas (boulevards) in the ROW are maintained by the adjacent property owner.

Maintenance:

 The easement area of each lot and all improvements in it shall be maintained continuously by the owner of the lot, except for those improvements for which a public authority or utility company is responsible.



Local News



Meals on Wheels of Tampa (MOW Tampa) is a community-funded organization that is expanding its services to residents of Riverview and Gibsonton this June. MOW currently serves 800 homebound residents in Hillsborough County. Applications from residents who are in need of meals will be taken mid-May. Volunteers (18 years and older) for drive routes and delivery of meals will also be accepted.

Because MOW of Tampa is an independent organization and doesn't accept government funding, it is able to accept any resident, regardless of age and income. If you or a loved one encounter difficulties getting out of the home or preparing meals due to mental or physical disability or age, MOW of Tampa can help.

They provide chef-created hot meals Monday through Friday with frozen meals being delivered on Friday for the weekend. MOW of Tampa also delivers fresh fruit and vegetables on the third Saturday of the month. In May, a hurricane preparedness package, including five shelf-stable meals, is delivered along with shelter information. At Thanksgiving, recipients are provided a treat bag, and in December, a great gift bag is given. They also celebrate birthdays with a card and a little something extra.

MOW of Tampa uses a sliding scale to determine if recipients will pay for their meals. Meals cost \$5.50 each meal. However, depending on their income/expense, recipients pay as little as \$0.50 or nothing. No one is ever turned away due to inability to pay.

The intake process takes approximately 15 to 20 minutes. If approved, services begin the next day. If a homebound individual has a pet, MOW of Tampa will refer them to the Humane Society of Tampa, and its mobile unit will come out with food for the pet. Cindy Vann, senior director of mission engagement, said, "MOW of Tampa allows senior and other homebound residents to live independently inn their homes with good, healthy, nutritious food and social contact almost every day." Vann added, "We have the most wonderful volunteers in the world. They connect with people who are often forgotten."

MOW of Tampa also has other programs that enrich the lives of the recipients such as Water on Wheels (WOW!), Produce on Wheels (POW!), Animeals, Hurricane Preparedness Packs, and Holiday.
